Teams will perform their state routines or any other style routine for feedback (no scores, only audio feedback) and then experience a one-hour perfecting session with one of our amazing dance team experts. Teams are welcome to bring as many team routines as they would like. Solos, duets, and trios are also welcome to perform for feedback. Performances and perfecting sessions will occur on either Friday or Saturday to accommodate any conflicts. For example, if a team has Friday conflicts, their performance(s) and perfecting session will both be on Saturday. Innovative Showcase will feature highly qualified dance team experts, KSHSAA and NFHS rules and regulations, honest critiques, and a preparation session where you can apply your critiques right away!

This showcase opportunity is not a competition and therefore does not count as one of the four competitions permitted by KSHSAA. Of note, the state competition does not count as one of the four either.

Friday and Saturday's schedules will be determined by the number of participating teams. Your showcase performance will occur prior to your one-hour session with a judge.

General admission will be \$5 each day. Each team will receive free admission for two coaches and one team manager.

<u>UPDATE FOR 2025:</u> We understand checks from schools can vary on timeliness and often are out of the control of the coach. However, we *must* have a PO in hand on or before 10/17. Entries without a PO or payment by 10/17 will be subject to a \$25 non-negotiable late fee.

### **Cancellations & Refunds**

- Cancellations received on or before October 17th are eligible for a full refund.
- Cancellations received between October 18th and October 24th are eligible for a 50% refund.
- Cancellations received on or after October 24th are not eligible for refunds. By 10/24/25, the schedule is finalized and therefore changes would affect the day of the showcase (holes in the schedules, staffing is finalized, etc).

- All routines have a three minute performance time limit.
- The Game Day category will follow the same structure as KSHSAA State. There are three components: performance routine, fight song, and spirit raising performance.
- Please bring your music digitally to the competition. A coach will press play at the Showcase.
- Innovative Showcase KC is a family friendly event. Avoid inappropriate movement/choreography (suggestive, thrusting, sexual, etc), music (curse words, suggestive lyrics, etc), and/or clothing (follow KSHSAA guidelines). Innovative Choreography reserves the right to edit (mute or bleep) inappropriate lyrics.
- We strongly believe in building an enthusiastic, supportive, and positive atmosphere among dancers, coaches, parents, and fans. Innovative Choreography and Shawnee Mission East will kindly ask those who do not follow this request to leave the event with no re-admittance nor refund of admission fees.
- KSHSAA and NFHS rules will apply to all Kansas teams.
- All performance music must be in compliance with all US copyright laws.
- No food or drink (with the exception of water) will be allowed in the dressing rooms or gymnasiums.
- Full payment must be received before Friday, November 7th, 2025. Innovative Choreography & Shawnee Mission East reserve the right to remove any routines that have not been fully paid for.
